In response to the recommendation for funding, the 1981 California legislature approved a \$90,000 yearly budget for the program's expansion, and this expansion was approved by the governor of California, effective July 1, 1981. The expansion was done under the directorship of Lois Shawver. The program continues to date and has been absorbed in the state of California standing budget.
- (7) In December of 1980, Psychologists in Public Service (PIPS), an officially recognized statewide organization of state employed psychologists, elected Lois Shawver President.
